Today a child is being born into a safe, loving environment. For the next five years they'll be nurtured and cared for. When they're hungry they'll be fed. When they're sick they'll be healed. And when they're old enough, they'll go to school. They'll learn and grow and prosper.

Because this child is being born in Bangladesh. Just 30 years ago, 150 children in every 1,000 born in Bangladesh never lived to see their fifth birthdays. This extraordinary change has been brought about by people like you. By supporting the work of Save the Children, you've created a present that, for hundreds of thousands of children, is significantly better than the past. But our work together is not yet complete. We still need to create a future where every child has a safe start in life. And where every child has the opportunity to thrive.

Shuma\* is the daughter and granddaughter of former sex workers in a large brothel in Bangladesh.


A brothel is a grim place to live for anyone, but especially for children, who are vulnerable to being coerced into the sex trade and are often subject to violence and abuse. Shuma knows that a brothel is no place for children to live.

Studying at a Save the Children-supported school for children from the brothel has given her big ambitions – she wants to be an English teacher when she grows up.

For Shuma, education is the key to finding a future away from the brothel. Thanks to Save the Children supporters, she's able to go to school, where she thrives in a stimulating and safe environment.

# EVERYBODY NEEDS A WILL

### Whatever your circumstances and however well-off you consider yourself to be, it's a good idea to have a Will.

A legally recognised Will is the only way to leave a true record of exactly what you want to happen to everything you own after you're gone. It can take away a lot of stress and worry for the people you leave behind, at what will inevitably be a difficult time for them. And it can give you peace of mind knowing that you've made provision for the family, friends and causes you really care about.

Having your Will drawn up by your lawyer is comparatively quick, easy and inexpensive. # YOUR WILL IS YOUR PARTING MESSAGE TO THE WORLD

Writing a Will is a sensible thing to do. But there's more to it than that. Because the process of deciding who you want to provide for when you're gone invites you to think about the people and issues that have mattered to you in your life. Your Will becomes a message – a statement of who you are.

So once you know you've provided for family and friends, you can also use your Will to support the causes you really care about – like the children of the world.

It's easy to include a gift to Save the Children in your Will. The value of that gift is of course entirely up to you. No matter what it is, it will make a difference. And it can take one of three different forms:

- A 'residuary gift' is a share of what remains of your estate once your other wishes have been carried out. Many people see this as the ideal way to support a charity like Save the Children, as it ensures your immediate loved ones take priority.
- A 'pecuniary gift' is a financial donation of a fixed amount – although it's worth remembering that, due to inflation, the value of this type of gift may have decreased by the time of your death.
- A 'specific gift' is a possession or item such as jewellery, property or shares.

If you already have a Will, it's easy to amend it to include Save the Children. You just need to ask a lawyer to write and attach a 'codicil' – a legally recognised addition or amendment to your Will. 'Like Eglantyne, I believe that "the future of the world rests with the child". In the years to come I know that Save the Children will use my Legacy to help children in need of care, protection and education.' Leaving a gift in your Will to Save the Children is the ultimate expression of your support for the world's most vulnerable children, and we wish to honour your commitment to them through membership of the Eglantyne Jebb Society.

Eglantyne later drafted the Declaration of the Rights of the Child, which evolved into the United Nations Convention on the Rights of the Child, today's most universally accepted human rights treaty. Everything Eglantyne stood for, Save the Children still fights for today.


Anwar's mother

Anwar\*, a Rohingya child living in a refugee camp in Bangladesh, was dangerously ill with pneumonia and was struggling to breathe.

Pneumonia is a curable disease but he needed medicine and qualified medical staff to save his life. His mother was able to get him to a Save the Children medical centre in the camp, where he got the life-saving treatment he needed. He made a full recovery and a happy, healthy Anwar returned home to his family.

A gift in your Will can provide such life-saving medical treatment for children like Anwar, well into the future.

# YOUR QUESTIONS ANSWERED

### Why should I make a Will?

Making a Will is the only way you can be sure your wishes will be met after you die. Dying without a Will – 'intestate' – can cause unnecessary distress to family and friends.

### How can I include Save the Children in my Will?

There are three types of gift you can consider. A 'residuary gift' is a share of what remains of your estate once your other wishes have been carried out. A 'pecuniary gift' is a financial donation of a fixed amount. And a 'specific gift' is a possession or item such as jewellery, property or shares.

### How do I prepare for a meeting with my lawyer?

Before meeting your lawyer, you might want to use the Estate Value Calculator we've provided to get a top-line value of your estate. You should also consider whom you would like to act as your executor. They could be a close friend, a family member or your lawyer.

### Can I write my own Will?

Any errors in a Will can cause problems and make it invalid. That's why we strongly recommend that you use a qualified lawyer.

### What if I already have a Will?

You can amend an existing Will to include Save the Children very simply by asking your lawyer to draw up a 'codicil'.

### What essential information will I need to give my lawyer?

You will need to give your lawyer our registered charity number, CC25367, and our address, PO Box 6584, Marion Square, Wellington 6141. You should also advise whether you'd like to leave a residuary, pecuniary or specific gift.

### Should I tell Save the Children I've included you in my Will?

Your Will is a very personal document and you're under no obligation to let us know if you've included a gift to us. However, it's enormously helpful if we do know your intentions. That way we can make sure we only send you information that's helpful and relevant to your circumstances and invite you to appropriate events. We'd also like the chance to say 'Thank you'!

There's a response form at the back of this Guide, with a reply-paid envelope, if you'd like to tell us of your gift.

# GLOSSARY OF LEGAL TERMS

### Will:

A legal document setting out what you want to happen to your estate when you die.

### Estate:

Everything you own and any debts you have at the time of your death. Any debts will be paid out of the value of your estate.

### Legacy or bequest:

A gift left in your Will.

### **Beneficiary:**

Any person or organisation to whom you leave a gift in your Will.

### Codicil:

An addition or amendment to an existing Will.

### **Executor:**

The person or people you choose to carry out the provisions in your Will in the event of your death.

### A testator/testatrix:

The person making a Will.

### Intestate:

A term to describe a person who dies without having made a Will.

### **Residue:**

What's left of an estate after funeral expenses, debts, legacies and taxes have all been paid.
